### Declaration

I also agree to the following:

- I will not bring a sick horse to MSEP.
- In the event that my horse does become sick/injured whilst at MSEP or that I call a vet for any purpose whilst at MSEP, I will advise MSEP immediately.
- I will observe good biosecurity practices whilst at MSEP and wash hands and equipment regularly.
- Shampoo, rinse and dry animals prior to movement and ensure hooves are clean of all solid matter.
- Ensure all vehicles/equipment accompanying the animal will be in clean condition at the commencement of travel to MSEP.
- I agree to abide by all conditions and directions given by MSEP staff, Event organiser or any other authorizing body.
- I acknowledge that failure to comply with the above may result in refusal of entry to the venue; disqualification or disciplinary action as decided by MSEP
  or the Event organisers.
- I acknowledge that there is a possibility that horses/animals might become infected with disease agents as a result of any movements and if necessary
  horses/animals may be quarantined in accordance with legislation covering such occurrences including policies and procedures in effect at that time.
- In the event of horse movement restrictions, each owners/person in charge will be responsible for care, maintenance and cost of their horses/animals, including feeding and watering.
- I agree and acknowledge that the venue, MSEP is in no way liable for any cost, expense, loss, damage, claim, action proceeding or other liability by or made against me as a result of any movement of horses to the venue and/or the event.
- The information supplied in this form is true and correct, to the best of my knowledge.
